AGREEMENT FOR SERVICES CONTRACT

Whereas CUSTOMER desires to hire the services of COMPANY for the following:

To provide usual and customary services to enable CUSTOMER to hunt _____

Alberta Season. In addition COMPANY is to specifically provide: transportation during the hunt, 2x1 guiding, meals and accommodations during the hunt, field care of game and trophies while in hunting area. This agreement may not be modified except by mutual consent of CUSTOMER and COMPANY.

CUSTOMER agrees to **provide:**

1. Gun or Bow, ammunition and all personal items necessary for this trip
2. Transportation to and from his/her residence including air transportation and car rental to hunt camp.
3. Handling of meat and/or trophies upon returning to the source of the trip
4. Any food and lodging before or after the hunting trip
5. License Fees and GST on the cost of the hunt

CUSTOMER specifically acknowledges that outdoor trips are by nature affected by circumstances (weather as an example) beyond the control of COMPANY and such circumstances may cause outdoor activities to become impractical or unsafe and therefore agrees that COMPANY has the sole right to cause activities to cease until COMPANY feels conditions are again safe to continue usual activities of this trip. In the event of such a decision by COMPANY, CUSTOMER agrees that any adjustment in fees for services or rescheduling of activities shall be at the sole discretion of the COMPANY.

CUSTOMER agrees to obtain and acquaint himself/herself with the laws and regulations of the province or country where hunting is to take place and to abide strictly by all pertinent laws and regulations applicable.

CUSTOMER agrees to conduct his/her activities during the trip in a lawful and ethical manner and to hunt within the guidelines only.

CUSTOMER agrees that in event of CUSTOMER'S failure to protect himself/herself at source of trip on time for any reason, (except death of CUSTOMER or OUTFITTER or serious illness documented by two physicians or death in the immediate family of CUSTOMER) his deposit will be forfeited.

CUSTOMER agrees to pay any remaining balance of fees due COMPANY in cash or Money Order, prior to receiving any services from COMPANY.

COMPANY agrees to make a reasonable effort to assist CUSTOMER in collecting the aforementioned species, CUSTOMER agrees that COMPANY is not guaranteeing any results of hunting.

The total cost of COMPANY'S services for this trip is in US FUNDS \$ _____ and \$ _____

is hereby enclosed as security deposit (International Money Order, Certified Cheque or Bank Wire Transfer) and upon receipt and acceptance by COMPANY or COMPANY'S AGENT, COMPANY agrees to reserve the herein described trip exclusively for the undersigned CUSTOMER.

This is not an offer for services. It will become a legal agreement only upon receipt, accompanied by required deposit and acceptance by COMPANY or COMPANY'S AGENT. This will become a legal document - if not thoroughly understood, seek legal counsel before signing, CUSTOMER represents that by CUSTOMER'S signature below, CUSTOMER has read and understands all the terms and conditions of this agreement and has satisfied himself/herself completely as to all details of this trip. Bookings are on a "First Come-First Served" basis. Time is of the essence.
